## **MINUTES**

### **AGENDA ITEM I - ROLL CALL, CALL TO ORDER, OPENING COMMENTS**

The Academic and Student Affairs Committee met on December 5, 2019, in Roaden University Center, Room 282. Chair Rose called the meeting to order at 11:35 a.m.

Chair Rose asked Kae Carpenter, Secretary, to call the roll. The following members were present:

Tennessee Tech faculty, staff, and members of the public were also in attendance.

### **AGENDA ITEM II - APPROVAL OF MINUTES**

Chair Rose asked if there were any recommendations or changes to the minutes. With no recommendations or changes, Trustee Hilliard moved that the Committee approve the September 24<sup>th</sup> Academic and Student Affairs Committee Minutes as presented. Trustee Wilmore seconded the motion. The motion carried unanimously.

### **AGENDA ITEM III - TTU POLICY 204 (FACULTY APPOINTMENTS)**

Provost Bruce stated that this policy establishes the criteria and processes regarding faculty appointments at Tennessee Tech. Revisions were made for clarification of lecturer and instructor positions.

Trustee Wilmore moved to send TTU Policy 204 (Faculty Appointments) as presented, to the Board for approval and to place it on the Board's consent agenda. Trustee Lowery seconded the motion. The motion carried unanimously.

#### **AGENDA ITEM IV - TTU POLICY 225 (NEW ACADEMIC PROGRAMS)**

Provost Bruce stated that this policy establishes an approval process for new academic programs at Tennessee Tech, consistent with the corresponding policy (A1.0) of the Tennessee Higher Education Commission. Revisions were made to reflect the changes made to the corresponding THEC policy.

Trustee Wilmore moved to send TTU Policy 225 (New Academic Programs) as presented, to the Board for approval and to place it on the Board's consent agenda. Trustee Hilliard seconded the motion. The motion carried unanimously.

#### **AGENDA ITEM V - TTU POLICY 271 (GENERAL GRADUATE DEGREE REQUIREMENTS)**

Provost Bruce stated that this policy describes graduate program requirements and procedures for Tennessee Tech academic units and graduate students. Minor revisions were made to provide clarity and allow students to be alerted sooner if they are at risk of dropping below a 3.0 GPA.

Trustee Wilmore moved to send TTU Policy 271 (General Graduate Degree Requirements) as presented, to the Board for approval and to place it on the Board's consent agenda. Trustee Lowery seconded the motion. The motion carried unanimously.

#### **AGENDA ITEM VI - TTU POLICY 1200 (UNDERGRADUATE ADMISSION REQUIREMENTS)**

Dr. Johnson stated that this policy creates uniform requirements for domestic undergraduate admission to Tennessee Tech. Revisions to this policy were made to reflect the undergraduate admission requirements already approved at Academic Council and the Tennessee Tech Board of Trustees.

Trustee Wilmore moved to send TTU Policy 1200 (Undergraduate Admission Requirements) as presented, to the Board for approval and to place it on the Board's consent agenda. Trustee Lowery seconded the motion. The motion carried unanimously.

#### **AGENDA ITEM VII - LETTER OF NOTIFICATION FOR BACHELOR OF SCIENCE IN FINE ARTS**

Provost Bruce stated that this degree provides additional educational opportunities and graduation pathways for students wishing to major in art or music in an accredited, regionally accessible program. The program is a Bachelor of Science in Fine Arts. This title

reflects a contemporary, wide-ranging and interdisciplinary arts approach, preparing students for numerous potential directions in visual art, craft, design, music or other fields of study.

Trustee Wilmore moved that the Committee approve the Letter of Notification for the Bachelor of Science in Fine Arts for submission to THEC. Trustee Lowery seconded the motion. The motion carried unanimously.

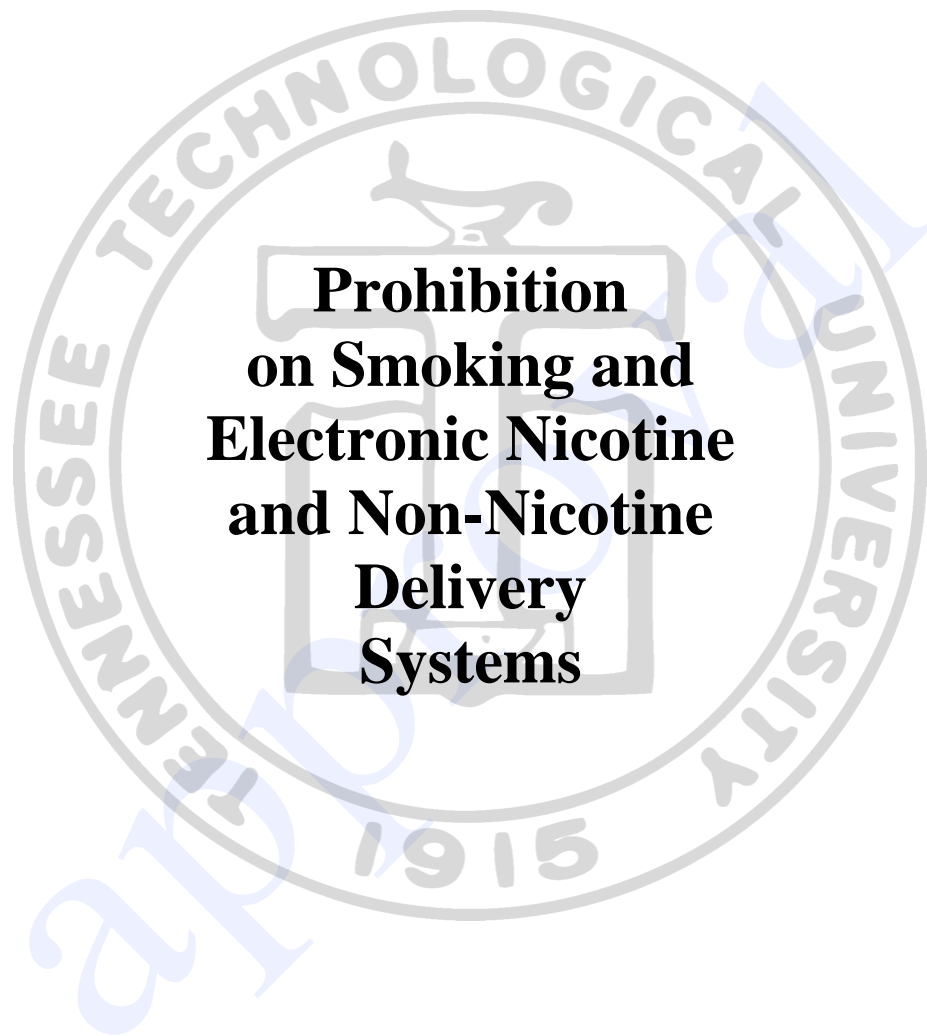

**Policy No.:** 171

**Policy Name:** Prohibition on Smoking and Electronic Nicotine and Non-Nicotine Delivery Systems

### **I. Purpose**

The purpose of this policy is to prohibit smoking, regardless of the substance smoked, or the use of electronic nicotine and non-nicotine delivery systems on Tennessee Tech property.

### **II. Review**

This policy will be reviewed every two years or whenever circumstances require review, whichever is earlier, by the Dean of Students Office, with recommendations for revision presented to the Administrative Council, University Assembly, and Board of Trustees.

### **III. Scope**

This policy applies to all Tennessee Tech administrators, faculty, staff, and students.

### **IV. Definition**

Electronic nicotine and non-nicotine delivery systems: devices capable of delivering any aerosolized substances including but not limited to nicotine, to the user.

### **V. Policy**

**A.** Smoking, regardless of the substance smoked, and use of electronic nicotine and non-nicotine delivery systems is not permitted on Tennessee Tech property, including but not limited to the following areas:

1. Tennessee Tech buildings and grounds;
2. Tennessee Tech affiliated off-campus locations and facilities;
3. Any buildings or properties owned, leased, or rented by Tennessee Tech; and
4. Tennessee Tech-owned or leased vehicles.

#### **B. Violation of Policy**

1. Administrators, Faculty, and Staff

Any employee who violates this policy will be referred to his/her supervisor for appropriate disciplinary action, pursuant to TTU Policy 650 (Disciplinary Action).

## **2. Students**

Any student who violates this policy will be referred to the Dean of Students Office for appropriate disciplinary action, pursuant to TTU Policy 302 (Student Conduct).

## **VI. Interpretation**

The Vice President for Student Affairs or his/her designee has the final authority to interpret the terms of this policy.

## Quality Assurance Funding

Quality Assurance Funding (QAF) incentivizes high-quality performance and provides a means of assessing the progress of student learning at public community colleges and universities. Tennessee was the pioneer in developing quality-based funding for higher education institutions and has become a model for states seeking to promote the highest standards and continuous improvement.



QAF standards are evaluated every five years to ensure alignment with state higher education priorities. The 2015-20 QAF cycle standards reflect current state priorities outlined in the 2015-25 Master Plan, guided by the Drive to 55, and continue to challenge institutions to promote the highest standards while carrying out their unique missions.

### 2015-20 QAF Defining Features

#### Academic Programs

When an appropriate accrediting agency is not available, institutions utilize program evaluations to ensure that academic program standards remain high through a self-study and external review. As part of the 2015-20 cycle standards review, program evaluation rubrics have been updated to reflect current best practices and align with the Commission on Colleges of the Southern Association of Colleges and Schools (SACSCOC) standards.

#### Institutional Satisfaction Study

In the 2015-20 QAF cycle, community colleges and universities will follow a unique schedule to engage various institutional stakeholders. Colleges and universities will use widely-respected surveys, employed at institutions across the country, to determine institutional satisfaction at the campuses.

#### Adult Learner Success

A major component of the 2015-25 Master Plan and Tennessee Reconnect is engaging adult learners. To support institutions in this critical mission, QAF implemented the Adult Learner Success standard focused on the unique experiences and challenges facing adult students. In 2015-16, institutions performed a self-study and gathered feedback from adult students that will help to create a campus-specific action plan for engaging adult learners. The standard also examined adult student graduation rates as compared to the institution's prior three-year average.

#### Tennessee Job Market Graduate Placement

The community college job placement standard utilizes data from the Tennessee Longitudinal Data System (TLDS) which combines data from the Tennessee Department of Education, Department of Labor and Workforce Development, and THEC. TLDS allows THEC to complete a statewide job placement analysis that is uniform across all community colleges, rather than through the use of surveys.

#### Student Access and Success

QAF focuses institutional attention on increasing the access and success of focus populations around the state. All institutions selected five populations on which to focus particular attention and resources throughout the 2015-20 QAF cycle. Low-income students and underrepresented race and ethnicity are the most common focus populations selected by colleges and universities, and eight institutions chose to concentrate on veterans.

### QAF and the Funding Formula

#### ***How do they work together? How are they different?***

QAF works hand-in-hand with the outcomes-based funding formula, with QAF complimenting the funding formula by providing an incentive for growth in outcomes to pair with a focus on quality. While state appropriations to each institution are largely determined through the funding formula, QAF provides an incentive for institutions to focus on outcomes as well as quality. QAF emphasizes quality of programs and success beyond graduation, ensuring that student outcomes are aligned with the state's higher education goals.
