## 6. Such Other Matters

J. Wendt shared informational item CI02.

J. Baker shared the next TN State Board of Education meeting is Friday, November 6. Voting on Educator Licensure Policy 5.502 that recommends pedagogical and content assessment requirements for a new Mathematics 6-10 endorsement and proposes revisions to postpone the increase in edTPA cut scores for one year to allow additional time for EPPs to refine practices and support student success.

J. Baker shared COEd was granted \$500,000 grow-your-own grant. Will partner with 6 Upper Cumberland districts – Putnam, Jackson, Overton, White, Warren, and Grundy – to enroll 30 teacher candidates (current teacher assistants and other community members).

L. Zagumny shared Tech's plans for Spring 2021. More consistent language to describe modalities is in place. Courses will be offered on campus, online, hybrid, synchronous, and asynchronous. Advisement starts Monday, November 9.
