Targets

- 1. The Office of Research set the target for Objective 1.1 at \$130,000 for the 2019/20 fiscal year to align with its goal for providing Faculty Research Grants and some travel funds to faculty.
- 2. The target for Objective 1.2 will continue to be 3% above (or 256) the 2018/19 target of 249 proposals submitted with a corresponding 3% increase in value above (or \$73M) the \$70.7M target in 2018/19 because we did not hit our target for last year. This decline in number of proposals submitted was the result of more collaborative proposals, involving several different faculty, that should result in larger funding results in later fiscal years.
- 3. The target for the number of proposal development workshops (training) in Objective 1.3 will remain at seven for the 2019/20 reporting period. Although are target will remain the same, we are continuously increasing the amount of training we provide as we highlight areas of great importance to funding agencies.
- 4. To align with the University's five-year initiative that calls for the \$20.2M in externally sponsored research earned in 2018/19 to be doubled, the Office of Research will set its 2019/20 target at 15% above the number and value of awards received in the 2018/19 reporting period. Therefore, the 2019/20 target for number of awards received will be 171, and the target value of those awards will be \$22.7M. If the target is increased 15% each year, the \$39.4M goal for 2024 should be achieved.

Goal 3: Identify activities that could potentially improve the economic environment of the region. *Objective 3.1:* Provide support to and collaborate with public and private sectors in economic development activities. *Method of Assessment:* Track number of projects resulting from industry contacts and the total amount of the contracts.

During the 2018/19 reporting period, 69 projects valuing \$72,575 resulted from industry contacts. These projects came through the testing facilities of our Centers of Excellence. Goal 3 Results

The ORED tracked progress toward Goal 3 in terms of number of projects resulting from industry contacts and the amount of funding earned from those projects, specifically by determining the number and amount of testing projects this fiscal year and the number of industry projects performed by students in their Capstone courses. Improvements to Assessment Plan

For 2020-2021, the ORED will continue to follow the implemented changes in how Goal 1, Objective 1.1, and Goal 3, Objective 3.1, were assessed. This year's results for Goal 1, Objective 1.1, included amount of initiation grants/support provided from Office of Research funds as well as Faculty Research Grants. The results for Goal 3, Objective 3.1, showed the number of Capstone design projects done by students for industry sponsors and the number and monetary value of service testing projects by the Centers of Excellence for external entities. These numbers better show whether industry contacts lead to tangible funded projects.

Modifications and Continuing Improvement to Goals/Objectives/Outcomes

The ORED conducts an annual qualitative survey to assess the level of interest and satisfaction in its resources and services. A summary of those results is in the Goal 1 results section.

The main themes of the 2019-2020 survey responses can be found in the attachment for Goal 1 (Copy of Results_2020ResearchAnnualSurvey.xlsx). The Provost's Office, in coordination with the Center for Innovation in Teaching and Learning, has been conducting training sessions for the faculty, and the ORED works with those offices to incorporate research-themed components. The ORED also plans to facilitate its own fall training workshops geared solely toward the research process.

The ORED plans to continue to produce its own email newsletter, featuring relevant information distributed to faculty and staff involved in the research process. Research-related announcements will also continue to be published in the *Tech Times*, which now features a research-only section.

These efforts will address comments in the survey to yield improved results in the 2020-2021 satisfaction survey. The ORED may consider revising the survey to provide more quantitative response and identify dominant themes.
