#### Enter New Business discussion:

President Lay presents Eathan Albert as official recommendation for the open senator position in ROTC. Motions passes with majority vote.

Secretary presents the first bill "Syllabus Act". The sponsor Senator Roth speaks on the behalf. Senator Johnson speaks on behalf of the bill when Senator Roth experiences technical difficulties. Amendment by Senator Tidwell: "In Section 1, strike the phrase "Act to Make Syllabi Accessible to Students" and replace it with "Syllabi Accessibility Act of 2021"." Amendment passes 22:0:0. Amendment by Senator Tidwell: "In Section 6, strike "in the 2021-2022 academic year" and replace with "immediately"." Amendment passes 20:4:0. Enter discussion. Senator McGee yields time to Rachel Baker, who yields time. Senator Tidwell moves to refer the bill to ad hock committee. Senator Johnson objects. Motion fails 18:5:1. Move to discussion of the bill itself. Senator Elliott yields her time to Senator Roth, who clarifies the purpose and wording of the bill for Senator Tidwell's previous amendment comments. Senator Hall is recognized, speaks in support of the bill and its wording. Senator Tidwell states bill is not worded correctly. Senator Hall yields her time to Madam Secretary, who clarifies the wording in the bill. End of Discussion. Motion to previous question. Bill passes as amended 24:1:2.

Secretary presents the second bill "Day of Service Act of 2021". The sponsor Senator Elliott speaks on behalf of the bill. Amendment by Senator Elliott: "Change title from 'An Act to Create a Tennessee Tech Day of Service' to 'A Resolution to Continue and Expand Tech Strong Day of Service'; change 'the spring break of 2021, March 15-19' to 'on March 3rd, 2021'; strike all operative clauses and move to preambulatory, fix grammar consequently; add 'we support that' before 'March 3rd will be annually...' and 'Tennessee Tech's University Service...' and 'Tennessee Tech's Office of Communications...'; add 'we recommend that' before 'in the future...'; add 'we recommend that' before 'the Student Government Association...'; add 'we recommend that' before 'organizations and offices...'; add as 10th preambulatory clause 'Whereas, if

March 3rd is a weekend day, we recommend that the Day of Service is postponed until the following week, and'; change Whereas clauses including "March 3rd, 2021" to correct past tense verbs; strike 'ENACTED' and add 'RESOLVED'"." Amendment passes 24:0:1. No further discussion, move to previous question. Resolution passes as amended 25:0:0.
